Notice of Direct Planning Application to An Coimisiún Pleanála  
in respect of a Strategic Infrastructure Development  
in County Galway.**

In accordance with section 182A of the Planning and Development Act 2000 (as amended), Bord Gáis Energy Limited gives notice of its intention to make an application to An Coimisiún Pleanála for approval for the proposed development of a 220kV Electrical Substation on lands at Rathmorrissy (Townland), Athenry, Co. Galway and the construction an underground grid connection route from the proposed Electrical Substation to the existing Cashla 220kV Substation. The grid connection route traverses approximately 8.1km along the L7109, L71093, L7108 and L3103 roads and across the townlands of Rathmorrissy, Pollnagroagh, Moanbaun, Castlelambert, Knocknacreeva, Caraunduff, Caherbriskau, Lisheenkyle East, Barrettspark, Cashla, Athenry, Co. Galway. The site area is 12.11 hectares.

The proposed development will consist of:

- The construction of a 4-bay 220kV electrical substation comprising of: one single-storey 220kV Air-Insulated Switchgear (AIS) Substation Building (approximately 388sqm) with welfare facilities, transformer, all associated electrical plant and apparatus, one telecommunication mast (approximately 36m high), security fencing, entrance gate, lighting, lightning masts, internal tracks, drainage (foul and storm), carparking (4 no. spaces), watermains and all ancillary works.
- The installation of 220kV underground electricity cabling connecting the proposed 220kV electrical substation to the existing Cashla 220kV substation within a trench, consisting of underground cabling and ducting, 10 no. joint bays and associated communication chambers and link boxes, 2 no. crossings of the M6 motorway and 1 no. crossing of the M17 motorway by way of horizontal directional drilling, and all associated site development and reinstatement works.

An Environmental Impact Assessment Report (EIAR) and a Natura Impact Statement (NIS) have been prepared in respect of the proposed development and accompany this planning application.

The proposed development will facilitate the export of electrical energy from a proposed natural gas fuelled electricity generation peaking plant, the 'Cashla Peaker Plant' on lands at Pollnagroagh and Rathmorrissy (Townlands), Athenry, Co. Galway which is the subject of a separate Strategic Infrastructure Development application to An Coimisiún Pleanála (Ref. ACP-324113-26) under section 37E of the Planning and Development Act 2000 (as amended). The Cashla Peaker Plant relates to development for the purposes an activity requiring an Industrial Emissions Licence from the Environmental Protection Agency under the Environmental Protection Agency Act 1992, as amended and also relates to a COMAH establishment and falls under the requirements of the Chemicals Act (Control of Major Accident Hazards Involving Dangerous Substances) Regulations, 2015. It is noted that the "project", subject of the EIAR and NIS, includes the Cashla Peaker Plant and Above-Ground Installation subject of the section 37E application (Ref. ACP-324113-26) and also includes the connection to the existing mains gas network (Mayo-Galway pipeline (BGE/85)) which will be undertaken via a new transmission pipeline (named GNI146) located within the townland of Rathmorrissy, Athenry, Co. Galway. A separate application to obtain approval for the GNI146 gas pipeline will be submitted under section 39A of the Gas Act 1976, as amended.

Notice of Direct Planning Application to An Coimisiún Pleanála in respect of a Strategic  
Infrastructure Development County Galway.**

In accordance with section 182A of the Planning and Development Act 2000 (as amended), Ballydonagh Solar Limited gives notice of its intention to make an application to An Coimisiún Pleanála for a ten-year planning permission in relation to the following proposed development within the townland of Ballydonagh Kiltomer, Co Galway.

The Proposed Development comprises the following infrastructure;

- A 110kV Air Insulated loop in/ loop out electricity substation (11,300m<sup>2</sup>) consisting of EirGrid control building (25m x 18m), customer control building (23.1m x 10.8m), 110kV bay arrangement, busbar infrastructure foundations, transformer, lightning masts, telecoms pole, CCTV, lighting columns, capacitor bank, reactor bank, harmonic filter, rural supply kiosk, house transformer, neutral earth resistor, resistor, stand by generator, compound roads, drainage, parking and hardstanding, palisade fence and gates.
- The grid connection will consist of the removal of c.248m of the existing overhead line and poles from Ennis- Agannygal-Shannonbridge 110kV circuit and the erection of two new towers (16m height) and c.975m of double 110kV underground circuit and tracks into the proposed substation.
- Remaining associated infrastructure consists of entrance; perimeter fencing, access tracks (1907m) (upgraded and localised widening) with water crossings; temporary construction compound; deposition areas (c.4300m<sup>3</sup>) and all associated and ancillary site development, excavation, construction, landscaping and reinstatement works and the provision of site drainage.

The site of the proposed development has a total area of 34.8 hectares. The Proposed Development comprises a 110kV Air Insulated Substation and associated grid connection infrastructure to facilitate the connection of the permitted Ballydonagh Solar Farm under Ref 2361049, as amended under Ref 25/61903 and Ballydonagh Solar Farm Extension under Ref 2461749, as amended under 26/60009, to the national grid. The applicant is seeking a **ten-year** permission from the date of consent of the 110kV Substation and grid connection.

A **Natura Impact Statement (NIS)** has been prepared and accompany this planning application.
